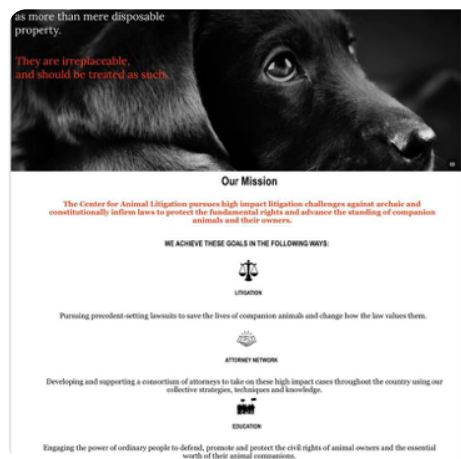

Good Tuesday morning before Thanksgiving to All,

In a few hours the killing will start at NYCACC. They are going to try to clear the place before the long holiday weekend.

Here's a bit of background on the challenges of bringing a lawsuit against NYC ACC and how we are strategizing to get this off the ground and filed. The founders of The Center for Animal Litigation, Thom Page and Richard Rosenthal, brought a lawsuit against NYC ACC three years ago on behalf of a dog being held on a kill order after several bite incidents. The dog got extremely sick in the ACC facility and almost died. They were able to ultimately save the dog and get him released back to his owners after 6+ months of litigating madly with NYC's legal department, but only under the condition that they dropped the lawsuit. Ever since, they have been searching for the right factual situation to be able to challenge ACC again. Thom and Richard are currently researching various legal theories for a lawsuit, depending on what factual situations are brought to their attention concerning NYC ACC, of which there are many, but not all issues with ACC lend themselves to a viable lawsuit.

One situation which would always be well worth investigating for a possible lawsuit against ACC is when a dog is being held by ACC AND the dog still has an owner (the dog(s) has not been surrendered and is not a stray, like the overwhelming majority of dogs they are holding and killing). If anyone knows of a situation like that, please contact Thom so they can review all possible options of using that situation to challenge ACC on behalf of all of the dogs they are holding, and ultimately the dogs they have killed already.

Thom and Richard are also continuing to look at other litigation options, and hopefully can soon find that opportunity, as well as be able to raise the funds necessary to sue the largest city in the country. The stakes are enormous for the City of NY and ACC, so they will fight this every step of the way, but Thom and Richard have done this before and are anxious and very committed to doing it again.

The animals in these ACC hellholes deserve nothing less from all of us. Many thanks for any donation you can make to help us pay the out of pocket costs the attorneys will incur, which will be in the thousands and thousands of dollars as the case moves forward.

We are all in this to finally achieve justice and true reform of how the lost, abandoned and injured animals in New York City are treated and should be cared for.

Thank you for all you can do to help us reach this goal.
